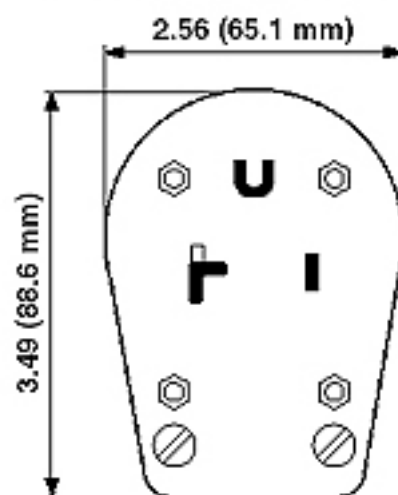

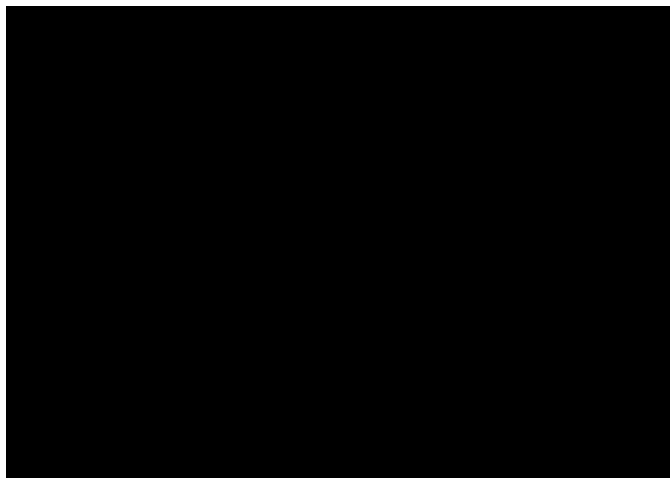
### Dimensional Diagram
